Leadership Committee Report and Elections

Andy Hammond, Chair of the District Leadership Committee presented his leadership report.

The District Leadership Committee is governed by Toastmasters International Protocol IX and I can confirm that we have fully complied with those rules and that our final report is therefore valid.

One requirement is to have a representation from each Division on the Committee and I would like to thank the following Committee members for all their hardwork and integrity throughout this process.

All Qualified candidates were interviewed by members of the Committee. We then voted on those to be nominated, and the list of nominations is on the next slide. Those are the nominated candidates as per your council pack for each of the roles and you will be voting on those later.

There were some changes to the rules this year, particularly, with regard to floor candidates. Only candidates who have been interviewed by the Committee, were permitted to stand as floor candidates, unless we did not nominate a candidate for any particular role. There was a further change on 6th April, where Toastmasters International announced an exception to the rules for floor candidates. That is in response for this District Council Meeting to be held online. All floor candidates were required to declare at least 7 days in advance and no nominations from the floor are allowed during the Council Meeting. That is a one off exception for this year. As a result of that requirement the declared floor candidates are as follows:

It looks a little odd, because if people want to stand for a subsequent division if they are not successful, they also had to declare 7 days in advance. So we have a number of floor candidates.

Division A had no nominated candidates so we have 2 floor candidates there.

Division D, the new Division, was only agreed a few minutes ago, so therefore we had no nominated candidates and we have 2 floor candidates there.

For Division L, the one candidate that we had nominated, withdrew after the report, so is only open to nominated candidates. We have 2 floor candidates for that division.

Subject to earlier elections, that is the status of our report and I can conclude there Mr District Director, Florian Bay.

The District Director thanked Andy and his team for all their hard work in selecting and interviewing candidates.

“How we use our money”. Mid-Year Audit and Update on District Budget

Violet Karamagi presented the District Budget and mid-year Audit. Please see attached slides 

Purpose & Key Points:

Violet explained how the Audit Committee had goals to achieve for the District, in a number of Areas including, Marketing, Education and Communication and we have an audit committee that makes sure that the money is spent in the right way.

The Audit Committee is Independent and it is made up of the Audit Chair, Guler Cortis and 2 members who, Michelle Senior & David Scott.

The Audit Committee goes through every single transaction the District does to ensure that everything has been recorded as it should be and to ensure that we are spending the money in the right way as we have been governed by Headquarters.
We get audited twice a year. We have a mid year audit which happens after December and that is done in January and then we have an end of year audit which is done in July. I can

report back on what happened in the mid-year audit.

All expenses were backed up with receipts and invoices confirming what the money had been spent on.

Some of the DD expenses could not be found on Concur our District expense management system and the reason for this is because expenses get approved by 2 people. Our District Director Florian Bay was our Programme Quality Director the year before so as such the approval levels had changed but it took some time for the system to change over. So we had to dig deep to find that the transactions had happened and the audit committee were happy that even the transactions that were missing on Concur had actually been recorded within the financial statements. So overall we have had a clean audit mid-year. Your money is being spent the way it should be. This is certified by the District Director and the Finance Manager who is myself, and the entire Committee.

The Finance Manager and the District Director are responsible to ensure that the District Finances are spent in the way they are meant to be spent.

Audit Certificate:

The Audit Certificate is signed by both the District Director and the Finance Manager. In addition, it is certified by the Audit Committee.

End of Quarter 3 Report as at 31st March 2020.

The Financial year runs from 1st July 2019 to 30th June 2020

Revenue: We were expecting to have £74,840 of revenue but unfortunately we have only had £70,887. The reason for this, which as you are all aware, we have had the Pandemic, which has affected renewals but then also Toastmasters extended the renewals deadline to 30th April 2020, so although we have the figures up to March, we have had more renewals coming in during April.

Fundraising income: We had a budget of £3000 but unfortunately we have not achieved this and that is mainly because most of our events were meant to take place in the second part of the year, and thanks to the Corona Virus, everything has been put on hold.

The District Store: We had a plan to have a district store whereby we would have supplies from Toastmasters International being held within the District rather than having them shipped from the USA. Unfortunately that has not happened either. That is why we have not had any revenue from that.

Speech Contest Revenue: That refers to all the Speech contests that were held at Division Level so the revenue that is showing in the numbers is for the Division contests that took place in November. Most of the Divisions has speech contests whereby they charged a fee

to help cover those expenses. As you can see we have a speech contests expenses line, so having a revenue generating event helps reduce expenditure on that particular event. Expenses: Fundraising expenses, we have not had any because we have not had any fundraising activities.

TLI Expenses: We budgeted to spend more. The figures that show were for events that happened between December and January so that has come in as less than expected.

Marketing: This is pretty much as budgeted for.

Communications and PR: This is a little bit lower than what we budgeted for.

Training and Education: We spent a little bit more than we had budgeted for. That is because we have had more District, Division Directors and Area Directors turning up at training events.

Admin Budget: This has been a little bit higher than expected because we held additional meetings as a District to get on top of all the unanticipated challenges that we have faced, and that is why our admin budget is higher than budgeted for but this will be less by the time we have finished the year.

Travel: This is a lot less than was budgeted for, but this is down to a reduction in travel, resulting from the Pandemic. Furthermore many of the London based Area Directors tend not to claim for their travel and that is because it is very easy to use your travel card to jump in and out of the trains. Many just do not bother claiming for travel expenses.

Other Expenses: ie Everything not listed above in slides, we are at Par.

Overall we have a shortfall of £3,827. This shortfall will be covered by the surplus that we have been building up over the years.

Secondly, looking at the coming year, as we are progressing, we hope to at least achieve a more positive figure than what we have at the end of March.

Q/Ans:

Gbemi Akojenu, K3 Where is revenue from the District Conference shown?

Florian Bay: It is not yet shown into that report because the Conference had not yet taken place before 31 March.

Richard Honeyman, VPE Lewes Speakers Club: Did today cost less or more compared to if not online? Any cancellation fees?

Florian Bay: This will be covered in the Slide no 2.

Nick Westall, President Excalibur Speakers, "Do you expect the end of year figure to be non-loss making?"

What has been the impact of Covid 19 on our District finances?

As anticipated our March income was £11,000 lower than what we had budgeted for because we were not sure what was going on. The Deadline extension of renewals til end of April also affected March income.

The good news is that our April income is at least £2,400 more than expected. People are gradually getting used to the fact that this is our new normal and people are meeting online. So income is coming in and will not be as low as before.

Overall our income is mainly driven by the late renewals and we will soon have more information now that we are going to close April. Hopefully by the time we close the year we will have a more solid figure of where we stand.

Just to clarify, although we have the information regarding the numbers, we work with HQ

to close the financial statements so our figures are not in real time exact. We have to go through a month end closing process with HQ. So as much as April has just ended, we will need to wait another 2-3 weeks before we have the final figures.

The District Conference: The Conference has actually done pretty well, in that we are expecting a net Conference income of about £7,000. So overall, our income shortfall against the budget, is likely to come in at about £4,000.

So what has been the impact of Covid, on our expenditure?

We have some unused expenses, so within our travel budget, we expect to have at least £7,000 less than expected, because we have all moved on line and travel is not an expense right now.

We have also saved on the attendance of District Executive Committee members, which we had planned for had this been in person.

We had budgeted for about £3,000 but as we met online, that has been saved. We have also saved another £2000 on room hire. So it has all been balanced out and we should finish the year in a strong position to carry on next year.

Q/A

Any questions regarding where we are financially?

Zariya Lufu, President Spirited Speakers, "I have just paid in some money last week so the amount should be higher.

We shall have better figures at the end of the year when we know exactly what has been going on.

Q:Simon Toon, VPE Berkhamsted, "So we expect to have £8k suplos at end of year?"

Ans: Florian Bay, District Director "Simon, it is not like we have a surplus of £8,000. It is just we will probably break even rather than have a surplus. We have been building up reserves , so we should still be in a good financial position. "

So I will use this opportunity to explain more of what has been happening in the world of finance.

I managed to collaborate with Brad Revell, and we had a webinar. Sadly it was not that well attended, but the training is available, as an evergreen webinar, and this was to support clubs in how to manage club finances. What tools are required. What questions one needs to ask. How does the Treasurer role interact with the rest of the Committee? And how the finances of each club should be managed, because this is one of the areas that gets ignored. So Brad and I got together and asked how best we can support the clubs and hence why we created this resource and that's available for anyone who needs it.

Another success for finance this year was on how Concur has been de-mystified. Concur is our expense management system and I have been blessed to do the Financial Manager role for 18 -20 months now. When I started Concur was very much a new resource. Many Area and Division directors struggled with how to use the system and there are still some people who struggle with it but overall, the number has been decreasing over time and that has really made me happy. It is a success in itself because people are able to claim back the expenses that they incurred rather than just leaving money falling down in the wind.

	<p>As previously mentioned we completed our mid-year audit successfully, and in time, so that was great.</p> <p>Our relationship with WHQ is also a lot better so when I started 18 months ago and first took on the role, HQ had moved its offices to Denver and pretty much all the support team in Finance was new so calling the Finance team was new. The HQ Team were finding their feet, trying to find out how things worked and getting to know everyone, things used to take a lot longer, but now over time, we have managed to overcome those challenges. The relationship between the District and WHQ is a lot better now.</p> <p>UK Bank Account: We opened a UK bank account. That has been a huge issue because, it is the first time that we have had a UK bank account. All our funds have previously been held in the US, which means expenses took a little bit longer and most importantly we incurred exchange rate fees, because our money was held in US dollars however our transacting was in pounds sterling which had let to our expenses growing more than we had wanted to. So having a UK bank account has allowed us to 1)Cut back on our exchange rate fees but also to pay our UK suppliers faster, because we use local suppliers for promotional materials. Or even the suppliers we use for conferences and being able to pay a supplier on time allows that relationship to thrive. Furthermore, having a thriving relationship in itself gives us an opportunity to negotiate discounts.</p> <p>We now also have a stripe account. Stripe is a payment platform which allows us to take card payments. Initially we used to rely on eventbrite for all our paid events and eventbrite fees were huge. On top of that you have to wait until an event has ended before you are able to get your money. With Stripe the fees are a lot lower. Moreover Stripe pays out every 3 days. So that has also been a big success. So it has been a great year and that is thanks to every one on the team and down to the clubs because at the end of the day no one is an island and it takes a team effort at the end of the day.</p> <p>Any Questions?</p> <p>Rober Granville, Malvern Speakers, “So I assume that TIWHQ has invested; in a licences for Concur?”</p> <p>Ans: Florian Bay, District Director. Ruth Ribeiro, District Administration Manager presents the District Administration Report. Good afternoon to the District Council. I should like to start off by explaining some of the things that I have go out of this role. Firstly Toastmasters is a place where we choose to learn and refine the core values of Toastmasters International, “Respect, Integrity, Service and Excellence” in collaboration with others. These core values spell RISE. Rise up into Leadership Potential.

Before joining the District Leadership Team, I was President of Riverside Communicators. That lit a spark in me and showed me my best self. I also attended two International Conferences in Chicago and Denver and Florian Bay, said that he saw something in me and he wanted me to be part of his team.

One of my strengths outside leading a club, is the ability to scribe. Whenever I am listening, I find myself writing. So what better task to do that be the District Administrator. As part of my role, I have been a part of the District Executive Committee, the District Council and the District Leadership Team.

As part of the District Leadership Team, we not only met 4 or 5 times in Person in different locations around the South of the UK, we also have virtual Sunday evening telephone calls, or Zoom Meetings, where we check in with each other and plan ahead for the next week.

In that meeting we check in with each other and we ask how we feel and what is going on for each other. That support has been absolutely incredible and I really treasure that. I love that about Toastmasters.

One of my roles is to take minutes of our meetings and you will know that those meetings are not always short. Some of them last 3-4 hours. Over the last couple of months, I have looked at how we can help clubs better understand those guidelines and how we can provide them with a clear framework to follow. We have taken some of the existing content and looked to refresh this and make it less staid and less dated. Fewer blocks of colour, to create more engaging and interesting designs, using motivational images with big headlines and simple, single-minded messages. We have looked at how we can use these messages and how they would look in different formats, or how they would look with different images in different styles, to inspire and to create more impactful messages. How we can utilize them for our District 91 incentives. How different formats and styles can really help stand out. How one recipe can create 5 Pizzas. We shall be finalizing these designs in the next coming weeks and we shall be creating a module for the club officer training. I hope you can see from the designs you have seen today, how we are trying to re-energize and really engage with our audience in a much more updated and inspiring way. Please remember, it is important to keep to brand guidelines. We work within the framework of Toastmasters and in all our communications, our aim is to drive club growth, club retention and club quality.

Club Growth Director, Helena Boden-Brewer.

Thank you to everyone that took part in that and they will be rolled out into May and June. There are also the Open house meetings. You can still claim £100 towards your marketing for that event. So please continue with that too! As we go forward, we have quite a lot of other things that we can do as we go into next year. Re-booting the trainers bureau. Let's get that up and running again and start providing online webinars to really help our members. We have embraced Webinars so far, and I would really like to thank Susan Rayner, our District PR Manager, for stepping in to help me, put together the surviving in online interviews webinar. We put that together in a week with the assistance of Theresa Dukes, to turn that around, to support our members that were going for online interviews, in the last couple of weeks. So thank you very much. Good luck to all of those who have gone to interviews so far, we will look to do more to support you and hopefully this will be our new norm. Good luck everybody. Programme Quality Director Report by Arnaud Sartre.

Good afternoon everyone again. Good afternoon District Council and everybody else watching us online. First of all let me take a moment to thank you all for the trust that you have put in me over the last few years and again earlier this morning during the elections.

As Programme Quality Director, this year, many activities have been taking part, but I will focus on only a few that have been extremely positive, and also demonstrating the breadth of activities of our District. First of all recognizing that over the last couple of months, we have been extremely successful in moving, not only our clubs, but also our contests, and we have also delivered an online club officer training for the very first time. So thank you everyone, who provided so much effort, in the background, and in the front line to deliver these activities. Thank you again so much for this.

The role of the Programme Quality Director is also to oversee conferences, and I am very pleased to report that this year is absolutely fantastic and I very much want to thank once again, our conference team and dozens of volunteers running behind the scene to make today and tomorrow happen. Thank you again so much.

We have clearly also had some challenges. There is no question about this and the next few months will certainly allow us to put greater plans in place to find a way to get back to a more normal place. Now on the Educational side, let me talk about Pathways for just a moment. Pathways enrolment has always been a key metric and month after month we are continuing to see an increase in our Pathways adoption. We are currently standing at just over 73% of our members. Not 100% as we would love to be and will have to be by the end of June, but certainly a move in the right direction. We have many clubs where all club officers are enrolled and I would very much continue to encourage all clubs to ensure all members, new and old continue and participate in the Pathways programme. This is essential for the continuation of our activities in the clubs.

Now talking of club activities and member recognition, we are as of only a few days ago, well over 1,300 educational awards. This is a tremendous achievement. We still have a number of legacy awards being credited to our members but the majority, about 2/3 of these awards are Pathways awards and I thank you all for your dedication to our current programme. With that in mind, we are probably on track to go slightly over 1,500, or 1,600 educational awards so far this year, which I believe will be another record breaking number, so thank you all for your time here. That concludes my report.
