18:40 Discussion on the format of District Speech Contests

Helena, District Director informed the DEC that we have been asked by Toastmasters International, on 10 June 2021, to decide the format of our Area, Division and District contests, the options being in person or online for the program year 2021/22.

<u>Debate</u>

Charlotte Hitchings, Area J7 Director spoke in favour of **in person**:

Charlotte was representing her area club views; four out of five of the area clubs wished to have contests in person and wanted this interaction between all clubs again.

Adrian Moore, Area H35 Director spoke in favour of **online**:

Adrian stated that there was still uncertainty over the pandemic and to allow certainty for planning and booking venues we should still stay online.

Helena, District Director asked for a second person to speak in favour of in person. After no further voting member stood forward to speak in favour of in person, Helena, District Director asked the Zoom Master, Peter Tate to launch the poll.



Andy Newman, CC announced the result:

- 82% voted in favour of online
- 18% voted in favour of in-person

Results were displayed on the screen for all DEC members to view.

Helena, District Director confirmed that the majority voted for online and that all Area, Division and Districts contests in this program year 2021-22 will be conducted online.
